**SECOND AMENDMENT OF
BY-LAWS**

RECITALS:

A. The Videra Drive Homeowner's Association (f/k/a Krumdieck Park) By-Laws were originally adopted on February 28, 1979 and duly recorded in the real property records of Lane County, Oregon on July 6, 1979, as Lane County Reception No. 1979-39600.

B. The Videra Drive Homeowner's Association (f/k/a Krumdieck Park) adopted new By-Laws on June 9, 1987, which were duly recorded in the real property records of Lane County, Oregon on August 11, 1987, as Lane County Reception No. 1987-34679.

C. A First Amendment to the June 9, 1987 By-Laws for Videra Drive Homeowner's Association (f/k/a Krumdieck Park) was adopted on August 6, 1990 and duly recorded in the real property records of Lane County, Oregon on July 18, 1991, as Lane County Reception No. 1991-33756.

D. Whereas, at a meeting duly and regularly called on March 5, 2014, pursuant to Article XII, Section 1 of the Videra Drive Homeowner's Association By-Laws, by a vote of a majority (33) of a quorum of members present in person or by proxy (36), the members of the Association changed Article III, Section 1 of the Association By-Laws, which sets the time and place for the Association's annual meetings.

NOW, THEREFORE,

RESOLVED: That Article III, Section 1, of the By-Laws referred to hereinabove is hereby changed and amended to read as follows:

**"ARTICLE III
MEETING OF MEMBERS**

Section 1. Annual Meetings. The annual meeting of members shall be held on the first Wednesday of March at 7:00 p.m. within the City of Eugene or at such other time or place as the Board determines appropriate."

FURTHER RESOLVED: Except as modified and amended herein, the By-Laws, as recorded as Lane County Reception No. 1987-34679 and as amended as Lane County Reception No. 1991-33756, shall remain in full force and effect.

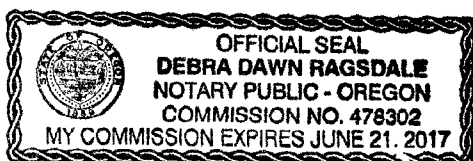
